

Changes to Our Terms and Conditions

An overview of the key changes and information about your right to object.

Hello liebes Talent,

We are updating our Terms and Conditions (T&Cs) for Talents effective **1 October 2026**.

With this update, we are standardising our contractual terms for all Talents and adapting individual provisions to reflect the continued development of our platform.

At the same time, we have distinguished more clearly between the rules for Self Service and Managed Service.

The key changes

Managed Service

For Managed Service projects, a standard 2.9% deduction for the early payment of your compensation (cash discount / skonto) will apply to **all Talents** in future. Previously, this rule applied only to Talents who registered after 1 April 2025.

The cash discount (Skonto) applies to services provided (revenue generated) from **1 October 2026** onwards, including under your existing Managed Service projects, if you do not object to the new T&Cs until **30 September 2026**.

The cash discount (Skonto) also applies if you object to the new T&Cs within the stated period but subsequently start a new project or a new Worktype within an ongoing project.

Self Service

For Self Service projects, we will introduce a **platform fee of 3%** of the compensation amount payable to you.

Important: The platform fee will **not be charged from 1 October 2026**. The required technical and billing-related prerequisites are expected to be in place during 2027.

We are informing you now because the new provision will be included in our T&Cs.

We will, of course, announce the specific start date at least **four weeks in advance**. Until then, you will not incur any costs for Self Service projects.

The platform fee applies to Self Service projects that you take on after the announced start date. From the announced start date, it will also apply to services provided (revenue generated) under your existing Self Service projects if you do not object to the new T&Cs until **30 September 2026**.

The fee also applies if you object to the new T&Cs within the stated period but subsequently start a new project or a new Worktype within an ongoing project. Rest assured that no platform fee will be charged retrospectively for services provided and billed before the announced start date.

Registration and use of the yoummday platform will remain free of charge. A cash discount (Skonto) or platform fee is only incurred if you carry out projects through the marketplace and generate revenue.

Further changes

- The same T&Cs will apply to all Talents in future, regardless of their registration date.
- The provisions for Self Service and Managed Service have been revised and explained more clearly.
- The T&Cs have also been updated from a legal and linguistic perspective and adapted to the current processes on our platform.

Why are we making these changes?

Managed Service

In Managed Service, you receive your compensation on the 18th of the following month, regardless of when the client pays its invoice. This means that we pre-finance the payment and assume the risk of late payment or non-payment. The 2.9% cash discount (Skonto) is deducted for this service.

Self Service

In Self Service, we also continuously develop our platform (marketplace) and invest in technology, security and reach so that you can access more clients and projects.

To continue offering these services over the long term and further expand the marketplace, we will introduce a moderate platform fee of 3%. We will continue to bear the majority of the associated costs ourselves.

Your right to object

You may object to the changes in text form **by 30 September 2026**. To do so, send an email to **talent-terms@yoummday.com**.

Important: If you **do not object** to the changes by this date and continue to use the yoummday platform **after 1 October 2026**, the new T&Cs will be deemed accepted.

If you object, the existing terms will continue to apply to your ongoing projects. However, you may only start new projects or new worktypes within ongoing projects if you accept the new T&Cs. Both you and we are entitled to terminate the platform-use agreement with 30 days' notice.
